A \$1,500 deposit to conduct a study is required for all meters 3" and larger and all tract maps.

T&M minimum deposit based on contractor quote for the job.

The meter installation charge is calculated to cover the cost of a typical meter installation. If the installation charges exceed the meter installation minimum deposit amount set out above (due to excess lateral, etc.) the customer will be billed for any balance due.

Maximum meter size allowed on parcel determined by parcel size. Resolution #117-14

In addition to the above pursuant to Ordinance No. 118-15 an IDA Special Connection Charge in the amount of \$8,400 per acre may be due.
