1. <u>Public Hearing on Proposed Resolution to Approve a Memorandum of Understanding Regarding Development of a Groundwater Basin and</u> Formation of a GSA.

Summary: A public hearing will be held at 2:10 p.m. to hear comments on the proposed resolution. The resolution will approve entering into a Memorandum of Understanding with the County of San Diego, Upper San Luis Rey Resource Conservation District, and the Pauma Valley Community Services District.

1-A. Proposed Resolution to Approve a Memorandum of Understanding Regarding Development of a Groundwater Basin Plan and Finding Approval of the Formation of a GSA Exempt From Review Under the California Environmental Quality Act.

Recommendation: That, should the Board approve of the drafted Memorandum of Understanding presented, the Board adopt the Resolution.

2. <u>Proposed Resolution Establishing the Appropriation Limit for Fiscal Year</u> 2017/18 Pursuant to Article XIIIB of California Constitution

3. <u>Proposed Resolution Awarding Contract for Wells 51 & 52 Pilot Holes and Cased Well (Fain Drilling).</u>

Background: Rebids for Wells No. 51 & 52 bids were opened on May 4, 2017. One bid for Well 51 in the amount of \$169,600 and one bid for Well 52 also in the amount of \$169,900 was received from Fain Drilling.

Recommendation: That the Board either reject all bids, a single bid, or approve one or both of the bids, and approve the Resolution Awarding the contract to Fain Drilling.

4. Review of the Principles of Understanding between the San Diego County Water
Authority, Valley Center Municipal Water District, and Yuima Municipal Water
District for the Delivery of Emergency Storage Project Flows at the VC1
Connection.

Background: To safeguard against a catastrophic or prolonged interruption of imported water supply, the San Diego County Water Authority approved the development of the Emergency Storage Project ("ESP"). The final phase of the

ESP is known as the North County ESP facilities, that will be used to serve both the Valley Center MWD and the Yuima MWD as described in the attached Principles of Understanding. The connection to the YMWD system will be made to our primary transmission main between the Forebay and McNally tanks. An important element of this project is that it may be used to supplement the District's water supply during non-emergency periods by providing an estimated 4.5 cfs to supplement current supplies during peak demand conditions, which will allow the District to avoid the costs of finding and implementing a supplemental peak demand supply. The District will have to negotiate a price to pay to Valley Center MWD for the use of the water during non-emergency periods. These costs will include capacity charges, power costs within VCMWD and other wheeling costs.

Recommendation: That, should the Board approve of the Principles of Understanding as presented, they direct the General Manager to execute the document.
