Rates shown below represent a 2.3% increase to the water commodity rate. There is no increase to the monthly meter charge or the pump zone charge.

The CWA/MET fixed charges will continue to be a *direct pass through* on the monthly water bill using each customer's rolling average usage based on the same methodology used by SDCWA to allocate their fees to the District. The pass-through charge adjustment will not take effect until **January 1, 2020**.
