6. **Review the Notice of Public Hearing for a Water Rate Increase.**

Background: Compliance with Proposition 218 requires the mailing of a *Notice of Public Hearing* of a proposed rate increase to all landowners and water customers in advance of the public hearing considering such rates. In order to meet the mailing requirements, notices will need to be mailed by May 14th for the hearing to be held on June 29th. Since this notice is required prior to our final budget projections it is proposed that the notice include wording up to a *maximum percentage* on all water, pumping, and meter related fees and charges. If it is determined that the increases are direct pass-through and include no local Yuima portion, then no notice is required as the prior resolution covered all direct pass through increases.

Recommendation: That the Board approve the proposed Notice of Public Hearing for the proposed rate increase.
