Background: The Master Plan is the District’s principle policy, planning and action guide for the ensuing 5 fiscal years. The Plan focuses on the major planning, operations, financial and capital project objectives that must be achieved to ensure that the District can continue to provide high-quality, reliable supplies of water to its customers in adequate quantities and at reasonable cost. The Plan primarily focuses on the operational requirements of the Fiscal Year 2016 – 2021 planning period, it also looks forward twenty years to FY 2036 in support of the District’s planning efforts as mandated by the California Urban Water Management Planning Act.

In preparation of the 2015 Master Plan document Staff will present data, including water rate and sales projections, staffing and secession planning, and needed capital facilities/projects.

Staff is requesting Board direction on various data inputs to the plan.
